

Since the new administration has come to office, actions that have been taken are resulting in a lot of uncertainty. This article is not about whether you like or dislike what is taking place with the federal government. It is about the uncertainty!

Decisions that have been made regarding the effort to stop government waste is hitting close to home. From what I have seen, some serious waste has been discovered. However, many programs that I view as needed have been put on hold. For example, federal funds for farmland preservation have been held up. One of the Soil & Water Districts in the state was awarded \$15 million to preserve farmland. The program is on hold without an answer as to what the future will be.

The Agricultural Development and Farmland Preservation fund depends on federal grants to match with state money to preserve farmland in the state. We do not know when or if the funds are going to be released. The Foundation for Soil & Water Conservation also depends on federal grants for some of the programs being conducted. When will the funds be released, if ever?

Are services going to be impacted? I read an article last week about the Farm Service Agency office in Wilkes County

being closed and employees reassigned to other locations. This means farmers will have to travel further to access these services. Some other offices in NC are also scheduled to be closed. These closures also apply to the Natural Resources and Conservation Service.

How will the closing of the US Education Department affect us? Maybe a lot. Maybe very little. Just more uncertainty.

Sometimes all of the things going on around us for which we have no control creates anxiety because things are changing and we do not know how they will impact us. It is certain that you have a voice. There are those who you can contact to view your concerns such as your member of congress and both senators. Keep in mind that they also have district offices. For agricultural related issues, you can also write the new Secretary of Agriculture. Writing the President is not out of the question. In all cases your communications should be respectful and civil because that is who we are as Grange members.

If we can be of help in the Grange office, let us know.

AMBASSADORS VISIT WASHINGTON DC



The National Grange Ambassador Team visited Washington, DC, in March to celebrate National Ag Day. Among the group were Taylor Rogers, National Youth Ambassador, and Laci Liles, National Junior Ambassador, both of North Carolina. The 5-day trip was packed full of events and was quite the journey for these young leaders.

Rogers and Liles were joined by the rest of their teammates, Young Adult Ambassador Ashlan Smith, Youth Ambassador Shae Smith, and Junior Ambassador Justin Dusko. The first day took them around our nation's capital where they visited monuments and museums including The People's House, a new museum full of interactive exhibits about the White House. They also engaged in discussion with National President Chris Hamp about shaping the future of our organization.

Their second day, March 17, the group started their morning attending a meeting with the House Ag Committee staff members. They gained much insight into legislative work and the committee's role in shaping agriculture policy. The afternoon took them to Farm Bureau where they networked with students from FFA, 4-H and AFA while learning more about the advocacy process and how to talk to leg-

Later in the day, the group attended a reception at the National Press Club, hosted by Agri-Pulse, before attending a pizza party on the rooftop of John Deere's headquarters. With a beautiful view of the White House, the Ambassadors enjoyed the pizza party which allowed time to mingle with other students and network John Deere leaders. On Tuesday, March 18, National Ag Day, the Ambassadors joined Grange staff at the official Ag Day kickoff at the USDA. After hearing from several speakers, our own Taylor Rogers participated in a student panel, representing the Grange. The discussion focused on the day's theme, "Together We Grow." Rogers emphasized the power of unity in agriculture stating, "Without being 'together' as a united front to fight for what we need in agriculture, we really can't get anything

done." She continued, "Being able to communicate with each other with a nonpartisan look, coming together not by political affiliation but by our beliefs in agriculture and what we want for the future, we can grow to build that future."

After the kickoff, students attended a USDA Careers Panel where they were inspired by several USDA staff members who offered excellent advice for the future. The afternoon brought a visit with the Senate Ag Committee staff for more discussion on the legislative process. During the afternoon, Liles and Rogers also took time to make visits to the offices of their NC legislators. Escorted by Jennie Gentry, the pair expressed the importance of funding and quicker support to all those affected in Western NC by Hurricane Helene. The day ended with a reception in the Kennedy Caucus Room of the US Senate.

Attending with the Ambassadors were two members of the National Grange Youth Advisory Council, the National Grange staff, and the Junior Ambassador's moms as chaperones. All did a great job representing the Grange. The busy week was full of excellent leadership opportunities for these young members who used their voices to support agriculture.



CAPITOL NEWS by: Laurie Barnhart



The North Carolina General Assembly has worked at an intense pace over the last few months, which is typical at this point in long session. All bills, with the exception of appropriation bills, had to be filed in the Senate by March 25 and in the House by April 10. 760 bills have been filed in the Senate

and 893 in House, bringing the total bills filed to 1653. The next bill deadline, referred to as Crossover, is May 8. As a reminder. Crossover is the last day for a bill to pass out of the chamber it was introduced in and crossover to the opposite chamber for consideration. If the bill does not make the deadline, the bill is considered dead. It can be revived by reintroducing a new bill in the next long session.

The budget process in the Senate has certainly been rolling along. This session, the Senate drafts their version of the 2025/26 budget first. It will then pass to the House where members will work on their version. The expectation is the Senate's budget will be released in late April.

A top priority for the General Assembly this session has been passing legislation providing disaster funding for aid to areas of

North Carolina affected by Hurricane Helene. There has been some hesitation to release funds due to the delay in funding from the Federal Government. If State funds are released too soon, it can affect the amount of funds appropriated from Congress. Thus far, four disaster funding bills have been passed and signed by the Governor, the

most recent being HB47 providing \$528 million in funding for those areas. There will be more funding to come. Following are ir State bills the NC Grange is watching. More information on the bills can be found at www.ncleg.gov/Legislation.

Governor Stein released his version of the budget on March 19. Key highlights of the Governor's budget proposal are below.

funding for schools and teacher raises

Stein is calling for over \$14 billion for education for each of the next two years, with a strong

emphasis on teacher pay and school infrastructure. His plan includes:

A 10.7% average pay increase for teachers over two years, making North Carolina's starting teacher salary the highest in the southeast

• A \$4 billion bond to improve school buildings, addressing aging infrastructure and crowded classrooms

- Hiring more school counselors, nurses and social workers to provide student support services
- Free breakfast for all public school students, ensuring children start the day with a meal
- Stein also proposes phasing out the Opportunity Scholarship Program, or school vouchers, and redirecting the money toward public education. The voucher program has the support of the Republican majority in the General Assembly.

Workforce development and tax relief

To strengthen North Carolina's workforce, the budget proposes:

- Free community college for students entering high-demand industries like health care and information technology
- Expanding apprenticeship programs, particularly in rural areas
- New tax credits for middle- and low-income families, potentially providing up to \$1,600 to some families

While Stein is pushing for tax relief for working families, his plan freezes the scheduled corporate and personal income tax cuts, keeping the individual tax rate at 4.25% and the corporate tax rate at 2.25% to maintain state revenue. Stein warns his budget office forecasts the state is facing an \$800 million revenue shortfall in two years.

Public safety and the opioid crisis

The proposal also aims to recruit and retain law enforcement officers by:

- Raising salaries for state law enforcement officers, including correctional officers and youth counselors
- Offering signing bonuses for new hires and out-of-state transfers
- Expanding resources for the fentanyl crisis, including a new fentanyl control unit to crack down on trafficking
- Funding more body cameras for law enforcement to improve transparency

The changing of the administration in DC in January has brought about enormous change in the Federal Government. Following are excerpts and highlights from National Grange's March recap, "View from the Hill."

USDA releases market, disaster, and conservation aid

Secretary Brooke Rollins has released the \$10 billion in market relief for row crop producers that was authorized by Congress in December. Congress also authorized \$21 billion in disaster aid will also be released. In addition, the department is releasing conservation program payments for the Environmental Quality Incentive Program (EQUIP), Conservation Security Program (CSP) and Agricultural Conservation Easement Program (ACEP).

Improper payments in SNAP and farm programs

The Government Accountability Office (GAO) says the USD-FA is one of 16 federal departments and agencies that reports improper payments totaling \$162 billion in fiscal 2024, including \$10.5 billion in the Supplemental Nutrition Assistance Program (SNAP). Significant improper payments were also found in farm commodities and conservation programs.

WOTUS to be revised

EPS Administrator Lee Zeldin says his agency and the Army Corps of Engineers will begin the work of coming up with a new rule to define to define Waters of the United States. Bodies of water that fall under the WOTUS definition are subject to federal jurisdiction under the Clean Water Act. Previous administrations, including those of Obama, Trump's first and Biden, have all tried to craft rules that would stand the test of time, but all attempts at doing so have been met with lawsuits. WOTUS is now defined one way in 24 states and another way in the remaining 26 as a result of these lawsuits.

With the cost of fuel, fertilizer, chemicals, and replacement livestock all on the rise, If you don't know of a Grange agent in your area, please conthis session was a necessity to attend. The presentation really caught my interest when they discussed the utilization of a area. Give us a call today and our insurance agents will make GPS system when reseeding, spraying, or spreading fertilizer on your pastures or hay fields. In the research, they equipped a single nozzle sprayer in an ATV (all-terrain vehicle) that had a wide spray pattern. Then, they had several ag interns spray the field without the GPS guidance. Those students had either spray overlaps or missing coverage of 10% and up to almost 35% in some areas. The average variance of coverage was around 20%. Next, the same individuals were allowed to use the GPS system installed in the ATV that gave a visual of the area sprayed. They could see where they were overlapping coverage as well as the areas they were completely missing. In these trials, the overlap or missed coverage was reduced down in the range of a low 2% to a maximum of 8%. With the cost associated with omission or overlapping, the GPS system could easily pay for itself very rapidly. Hence, we now have a portable GPS system that we can move between tractors and our ATV for such operations as needed for enhanced efficiency.

In thinking about the upcoming graduations from high school or college, who are you turning to for guidance for you, your child or grandchildren's life and or health insurance?
