

GUILFORD GRANGE

Guilford Grange, located in Greensboro, made several donations to various non-profit organizations in the community in the first six months of 2025.

On March 10, 2025, Guilford Grange Board members met with Candice Terrell, the leader of the Re-Cover Project, to donate \$1,500. The Re-Cover Project is a new non-profit that was founded around October 2024 due to the disaster in western North Carolina caused by Hurricane Helene. Volunteers spend countless hours sorting through good quality clothing that has been donated to be used for people impacted by the hurricane and other disasters in North Carolina. This wonderful organization helps support people when devastation has impacted their area.

On April 10, the Guilford Grange Board sent a check to the Second Harvest Food Bank for \$500. This has been an organization Guilford Grange has supported through the years. This organization provides food assistance to 18 counties in Northwest NC through a network of partners.

Another organization the Guilford Grange supports regularly is the Servant Center. On April 11, a donation was made for \$5,000 to support their efforts. The Servant Center empowers the homeless and disabled, particularly veterans, through housing, healthcare and restorative services. It is a United Way agency which serves over 2,000 people every year with housing, benefits assistance and resources for breaking cycles of homelessness.

On April 28, a \$500 donation was made to Western Guilford Middle School to support Teacher Appreciation at the end of the school year. The check was presented to Chase Arrington, Principal of the school, who is also a Board member of the Guilford Grange.

The Guilford Grange Board members have a passion for helping veterans, the homeless, those with food insecurity, and students in lower socioeconomic areas. With the help of matching money from the NC State Grange, we were able to donate a total of \$7,500 so far this year to help those in our community in need.

Grange Camp is, by far, the favorite event of the year for the kids in our organization. 
sponsor and pay for campers to attend this inspirational week.

CAPITOL NEWS by: Laurie Barnhart

The 2025 North Carolina General Assembly long session has been a bit challenging this year for anyone involved in the North Carolina legislation. Whether you are a member, staffer, lobbyist, etc., it was at times extremely hard to figure out what the next move was going to be. The two chambers were not able to agree on a two-year spending plan for FY 2025-27 prior to the beginning of the new fiscal year which started on July 1. It remains to be seen if they will reach agreement on a new budget. Should they not, the last budget remains in effect for all recurring expense items. Any non-recurring items ended on June 30 and funding would need to be reappropriated by the General Assembly.

The Senate and House did come to an agreement on a "mini-budget" bill at the end of July when they passed HB 125: Continuing Budget Operations. In effect, this bill addresses a few bigger issues that are time sensitive since a biennial budget could not be agreed upon by the two chambers. It addressed funding issues for such things as school enrollments and Medicaid rebase which is an adjustment to account for population growth and actual costs for covering the mandated services for those eligible for Medicaid. It also appropriated funds and policy direction to deal with the issues at DMV. It remains to be seen if the two chambers will agree on a new budget if they will possibly pass an another "mini-budget" bill.

Both chambers officially adjourned on July 31 and are to reconvene on Tuesday, August 26, 2025. All the details of adjournment were laid out in Senate Joint Resolution 772.

Besides passing Senate and House bills the last week of July, the legislature also took up veto overrides of the fourteen bills that Governor Stein vetoed earlier in the session. In the House, Republicans need at least one Democrat to vote with them, or enough members to be absent to achieve the three-fifths majority that is required to override the Governor's veto. The Senate Republicans have a super majority; so they do not need the Democratic vote. Both chambers have to override the veto for the bill to become law. The following bills have been overridden thus far by both chambers:

- H.B. 193 Firearm Law Revisions.
- S.B. 416 Personal Privacy Protection Act.
- H.B. 805 Prevent Sexual Exploitation/Women and Minors.
- S.B. 266 The Power Bill Reduction Act.
- S.B. 254 Charter School Changes.
- H.B. 549 Clarify Powers of State Auditor.
- H.B. 402 Limit Rules With Substantial Financial Costs.
- H.B. 318 The Criminal Illegal Alien Enforcement Act.

The following vetoed bill have not been overridden:

- S.B. 50 Freedom to Carry NC.
- S.B. 153 North Carolina Border Protection Act.
- S.B. 227 Eliminating "DEI" in Public Education.
- S.B. 558 Eliminating "DEI" in Public Higher Ed.
- H.B. 171 Equality in State Agencies/Prohibition on DEI.
- H.B. 96 Expedited Removal of Unauthorized Persons. (Note: a separate bill was passed that took out the Governor's exception to the puppy mill piece that the Senate added in the original bill.)

The North Carolina 2025 Farm Act, SB 639, introduced by Sen. Jackson, was passed in the Senate after a controversial few months over the raw milk provision in the bill was removed. This provision has always been a bone of contention. It is against the law in North Carolina to sell raw milk for human consumption unless it is labeled as "pet milk" or "not for human consumption." Because of reported pet cat deaths due to drinking "pet milk," the raw milk issue again came to the forefront.

Another point of contention and alarm is in Section 19 of the Farm Act which allows for pesticide manufacturers to be protected from liability if their product has a label approved by the US Environmental Protection Agency (EPA) under FIFRA, the Federal Insecticide Fungicide and Rodenticide Act.

The North Carolina Grange has grave concerns over the continuum of lawsuits that have been filed countrywide against Bayer CropScience for not warning their consumers on the labeling of glyphosate, the active ingredient in Roundup that purportedly causes cancer. For years, the Environmental Protection Agency (EPA), in spite of a multitude of scientific research through the years, has never found evidence that glyphosate causes cancer. The EPA dictates the required wording on product labeling. Because there is no evidence of glyphosate causing cancer, the EPA does not allow Bayer CropScience to label it as such. Bayer CropScience has paid approximately \$10 billion to settle these disputed claims to date, with 67,000 further cases still pending. Bayer has had to put aside \$5.9 billion in legal provisions because of these pending cases. Farmers have been depending on Roundup to help control weeds for over 50 years. It is used throughout the country and has been found to be a highly effective herbicide. (Info from Reuters) Glyphosate is mined in two locations in the world, Idaho and China.

The 2025 North Carolina Farm Act, Senate Bill 639, sponsored by Senators Brent Jackson, Norm Sanderson and Lisa Barns supports the legislation to clarify package labeling in Section 19 of the bill. It reads as follows:

Section 19: Establishes that the duty of a manufacturer or seller of a pesticide to warn a consumer or the public about the risks associated with the pesticide under GS 99B-5 (failure to warn claims) is presumed to be satisfied if the pesticide bears the label approved by the US EPA under the Federal Insecticide, Fungicide, and Rodenticide Act and the pesticide is registered with the Pesticide Board. Provides for rebuttal of the presumption, "Without this provision, North Carolina is opening a pathway for companies to be targeted by plaintiffs' attorneys for simply complying with federal law. The rigor of EPA requirements cannot be overstated, attempts to add a statelevel of regulation to that process will increase lawsuits and bigger pockets for plaintiffs' attorneys, but it will not do anything for farmer safety. (NC Chamber of Commerce)

A House Agriculture Committee member was able to pass an amendment that affectively removed the language from the bill. The revised bill was passed out of committee; however when it reached the Senate, members voted to non-concur and conferees where appointed to negotiate a solution. It will more than likely be taken up again at the end of August.

In Congress, the much talked about "Big Beautiful Bill" passed the US House on July 3 with 218 yeas and 214 nays. It was signed on July 4 by

President Trump.
The vote followed after an 8 hour and 44-minute speech by Minority Leader Hakeem Jeffries, D(NY) which delayed the final vote.

News that North

would not run
for reelection

next year came as a shock to North Carolinians. Sen. Tillis has served in the US Senate for ten years, also serving previously in the NC House from 2007 to 2015, and as the House Speaker from 2007 to 2015. The NC Grange has worked with Sen. Tillis and his staff closely during his tenure. We will miss the relationship we established with his office.

The NC Grange signed onto a letter this in July to Secretary Kennedy, Secretary Rollins, and Administrator Zeldin, urging them to ensure food and agriculture have a seat at the table during the development of policy recommendations related to the recent Make America Healthy Again (MAHA). The letter was signed by organizations representing millions of farmers, ranchers, food producers, and ingredient manufacturers. We are pleased to see the MAHA committee has since included farmers in their meetings.

HEALTH CARE INSURANCE CHANGES ARE A COMING!

July was a very active month for precipitating coming health insurance changes, both on a national and state level. Will those changes be good or bad? Only time will tell that answer. In the short time, there will be a lot of anxiety for individuals, insurance agents, insurance carriers, as well as county, state and federal employees as these mandated changes take effect, and processes of engagement are established and then acclimated.

So, what are some of the major changes cited in the "Big Beautiful Bill" that will affect us here in North Carolina?

For those Under 65:

The bill now requires all recipients of marketplace health insurance premium subsidies, also referred to as advanced premium tax credits, to verify their household income. This means that those wanting to renew their current coverage will need to provide a form of acceptable income verification prior to their renewal for continual coverage with subsidies applied. We anticipate that the insured could themselves or provide their agent with this verification for uploading to the Marketplace to satisfy this new requirement of everyone. In years past, the insureds were automatically re-enrolled and continued to receive their prior year's subsidy until either they updated their stated income or chosen by the Marketplace to submit current income verification. Pre-enrollment verification that the individual/family is eligible for subsidy is also a new twist to encounter in 2026. Previously, the insured had a limited time to provide marketplace verification, yet the subsidy always began on the policy's effective date. With the new provision the subsidy can only start post verification. Another major change revolves around the understating of household earnings. Previously, there was a limitation amount on the recapture of overpaid subsidy amounts that the government could collect. The new law eliminated this limitation, so it becomes imperative that the estimation of projected income be as accurate as possible and if there are changes occurring during the year, then an updated household income need reporting to the marketplace for a subsidy recalculation to avoid a significant recaptured subsidy amount.

This new requirement is going to create some additional workload for your agent, but it will also provide a great opportunity for the insured and the agent to review the current coverage levels and make sure that the insured has the best plan for their individual situation. However, schedule your review appointment early as the enrollment annual enroll-

ment period has rolled back to November 1 through December 15 as it was originally in the ACA legislation.

The effects of this bill are less pronounced on Medicare recipients. Upon reading the Senate Finance Committee notes on this bill, the major change is limiting non-citizen eligibility for Medicare benefits. Then new bill limits benefits to lawful permanent residents, certain Cuban Immigrants and Citizens of the Freely Associated States. Any prior non-citizens receiving Medicare benefits will cease, effective one year after the date of enactment of the law, if they are not in one or more of the above three classes.

Current and potential Medicaid enrollees will see the largest effects of the new law. A significant change is the requirement of "specified non-pregnant, nondisabled, child less adults, aged 19 through 64, to complete a minimum of 80 hours of qualifying community engagement activities." There is a safety net for many individuals who have a significant disability, medically frail, caretakers of young children or disabled persons from this requirement. There are also "good cause" exemptions like natural disasters or excessive unemployment rates in their area. Examples of the required community involvement include work or participation in a work, community service, or educational program(s). Medicare enrollees will have at least three months prior notification before this becomes effective to document their case of exemption or compliance to this requirement. Recently a friend reminded me that this is not a new concept for Medicaid enrollees. In the 1990s, President Clinton proposed this as part of his welfare reform efforts.

Further changes include required eligibility redeterminations every six months versus annually and the required verification of citizenship, nationality or satisfactory immigration status for Medicaid eligibility. There is also an elimination of alien eligibility except for those lawful permanent residents, certain Cuban immigrants and individuals living in the US through the Compact of Free Association.

There is also a cost share requirement of up to \$35.00 for certain medical services, excluding but not limited to primary, prenatal, pediatric care, for Medicaid enrollees with certain income levels.

States must review death records as well as cross check for Medicare Enrollees possibly receiving benefits in another state on a monthly or quarterly basis to eliminate unwarranted payments.

This bill introduces several changes that will take effect in the coming year and beyond. So, will it be beneficial to the citizens of North Carolina? I'm sure that there will be some individuals that suffer some adversity with the passage of this legislation, however, we normally do grow stronger as we go through hard times. We will have to wait to see what the long-term gains or losses will be. In the meantime, I'll encourage you to read the bill yourself to form your own educated opinion versus just listening to either party spin their opinions or taking their word as the gospel. Identify both the positive aspects and potential challenges and communicate your observations to your Federal and State Representatives.
